#### CAMPUS LOCATION

The Institute looks forward to welcoming you to Mikocheni for the start of your academic programme on 10<sup>th</sup> October, 2016. The following information is provided in order to help you to plan your arrival so as to enable you arrive well prepared to complete the programme into which you have been admitted. The Institute is located at Mikocheni B Area along ITV Road in Dar es Salaam about two kilometers from Mwenge bus Stand.

#### **ARRIVAL INSTRUCTIONS**

You are expected to arrive at the Institute as follows:-

• Full-time students: 08.30 hrs on 10<sup>th</sup> October, 2016

• Part-time students: 08:30 hrs on 10<sup>th</sup> October, 2016

#### REGISTRATION

You will be required to register formally in order to become a student of the Institute. The following are needed before registration is done:-

- (i) Duly filled in Registration Form;
- (ii) Academic Certificates (Original) and a copy;
- (iii) Four passport size photos, and
- (iv) Birth Certificate (Original) and copy
- (v) Evidence of payment of relevant semester fees (in full).

#### **IMPORTANT**

You will only be able to register if the above documents and payment have been received. Please note that submission of a duly filled in and signed registration form implies your acceptance of all the conditions stipulated herein and in other official publications of the Institute.

#### **FEES**

Programme fees are payable in full prior to registration in favor of ITA Fees Collection Account No. 0150303205600 at CRDB bank. For the case of foreign students fees should be paid in A/C No. 3300481074 Kenya Commercial Bank (Tanzania) Limited, swift code: KCBLTZTZ.

#### ALLOWANCE AND OTHER CHARGES

There are a number of allowances that students registered into the above programmes are entitled to. These may be paid by sponsor directly to students and they include:

- (i) Books and stationery allowance at the rate of shillings 400,000 (USD 250) and 200,000 (USD 125) for postgraduate students and other students respectively.
- (ii) Research project/dissertation allowance at the rate of shillings 500,000 (USD 313) for master's students and shillings 300,000 (USD 188) for other postgraduate students.

#### **CAMPUS FACILITIES AS**

(i) On –campus accommodation

The Institute has no on- campus accommodation facilities (hostels). Students are advised to search for accommodation in the Institute's neighborhood areas.

(ii) On-campus meals

Meals are provided at campus on cost basis. Students are responsible for paying for their day meals. The cost for day meal ranges but at minimum student requires Tshs 5000 for on campus meals.

#### REFUND POLICY

Except where a particular payment to the Institute is expressly stated to be non-refundable, refund shall be made in accordance with the refund policy of the Institute applicable at the time the application for the refund is received. This policy will be issued by the Deputy Rector (ARC) upon request

#### **MEET AND GREET**

The Institute runs a meet and greet event for new students before starting their studies. This is designed to orient you to the Institute's life and enable you to meet your fellow students, staff and members of the Institute's Management. Full details will be given to you at registration.

#### LATE ARRIVAL

We aim to offer the best possible service to our students. Arrival after 10<sup>th</sup> October, 2016 is permitted **only in exceptional circumstances** and with the permission of the Rector. If you have reason to think that your arrival might be delayed, please contact the Institute well in advance so that special arrangements can be made for you. Places cannot be held open beyond the first day of the programme unless permission has been obtained in advance.

#### **HEALTH**

Although the Institute does not provide medical services on campus, first aid services can be offered on campus as and when needed. There are several reputable hospitals in the vicinity of the campus. Medical cost for TRA –sponsored students will be met by the TRA in accordance with existing staff policy. All other students must provide evidence of medical coverage. Students who have subscribed to the National Health Insurance Fund should submit copy of the NHIF Identification Card. Students who do not have evidence of Medical Cover shall be required to pay National Health Insurance Fund (NHIF) subscription fee, forms will be made available at the Institute upon registration. Cost for Health Insurance will be met by students themselves (**included in the fee structure**). In case of need for emergence medical attention, the Institute provides free transport to the nearest reputable hospital.
